EARL PARK FALL FESTIVAL 2019 FLEA MARKET GUIDELINES

- DAVE SHCUTTER WILL GUIDE YOU TO YOUR DESIGNATED SPOT OR SPOTS.
- DO NOT PARK OR SET-UP UNTIL YOU HAVE TALKED TO DAVE SCHUTTER. (765-491-7442) or PAM ISHMIEL 765-586-9868
- Check our website (www.earlparkfestival.com/Events/flea.htm) for parking hours.
- If reservation form and payment are not received by July 1, 2019, your spot may be sold to another vendor.
- Merchandise sold is at the discretion of the Earl Park Fall Festival Committee.
- There is no guarantee of electricity or water.
- No generators or air conditioners are to be used.
- No subleasing of lot(s) or selling your lot(s) to someone else.
- Set-up is for all 4 days or Jockey Lots by the Day
- All lots purchased must have sellable merchandise on them. Lots cannot be used solely for vehicle storage or camping.
- ALL VENDERS WITH CAMPER ARE TO HAVE THEIR CAMPER ON PAID VENDER SPOT OR SEPARATE CHARGE FOR CAMPING WILL BE CHARGED
- Allow for the space you need (including trailer hitches and awnings). Please do not overhang onto your neighbor's lot. Lot size is 22' x 20'.
- We will try to put you in the same area, but we cannot guarantee the same spot every year.
- No vehicles are allowed in the Flea Market area. They must be removed from 9:00 am to 9:00 pm during the Festival. You may pull out on Monday once the Parade has started.
- If you are a food vendor, it is your responsibility to get a permit from the Benton County Health Department. Food vendors must have a valid permit to operate at the Festival. You will be shut down if you do not comply. For more information, contact the Benton County Health Department at (765) 884-1728.
- You must have an Indiana Tax ID Number. Contact the State of Indiana Department of Revenue to obtain such number.
- Children are not to use the Flea Market area as a playground area at any time. The park closes at 11:00 pm and all children under the age of 18 must be at their campsite or flea market site under adult supervision.
- **NOTICE: Due to repeated past problems with irresponsible pets owners and aggressive animals, and for the enjoyment and safety of all of our guests, no pets* are allowed anywhere on the grounds of the festival! Please plan accordingly. *With the exception of service animals**

FORBIDDEN ITEMS

- No toys may be sold that shoot any type of projectile of any kind.
- No firearms or weapons of any type will be allowed.
- KNIVES: Legal knives may only be sold to those 18 year olds of age and older with proper photo ID.
- No bug fogger use is allowed in the Flea Market area.
