2024 FLEA MARKET GUIDELINES

ADDITIONS!!!!!!**

- **DO NOT PARK OR SET-UP UNTIL YOU HAVE TALKED TO DAVE (765)-490-1702, AUDREY (765)-267-0281 or CINDY (765)-385-8006**
- **DAVE SCHUTTER WILL GUIDE YOU TO YOUR DESIGNATED SPOT(S) –**
- **WEEKEND VENDORS MUST BE IN DESIGNATED LOT BY FRIDAY AT 3PM**
- **you may arrive as early as Wednesday after 9am IF you have made arrangements with one of the individuals listed above**
- Merchandise sold is at the discretion of the Earl Park Fall Festival Committee
- **There is no guarantee of electricity or water. We also cannot guarantee that there will or will not be a tree within your spot**
- No generators or air conditioners are to be used
- No subleasing of lot(s) or selling your lot(s) to someone else
- **Set-up is for all 4 days or Jockey Lots by the day – if you set up for more than one day it is \$130**
- All lots purchased must have sellable merchandise on them. **Lots cannot be used solely for vehicle storage or camping** – Allow for the space you need (including trailer hitches and awnings. Please do not overhang onto your neighbor's lot. **Lot size is 20' X 20'**
- **IF YOU NEED A CAMPING SPOT YOU MUST CONTACT VALERIE MURPHY AT 765-491-3582**
- We will try to put you in the same area, but we cannot guarantee the same spot every year
- **No vehicles are allowed in the Flea Market area.** Please try and have your items unloaded and vehicle moved within one hour after arriving.
- If you are a food vendor, it is your responsibility to get a permit from the Benton County Health Department. Food vendors must have a valid permit to operate at the Festival. You will be shut down if you do not comply. For more information, contact the Benton County Health Department at (765)-884-1728
- You must have an Indiana Tax ID Number. Contact the State of Indiana Department of Revenue to obtain such number
- Children are not to use the Flea Market as a playground area at any time. The park closes at 11:00 p.m. and all children under the age of 18 must be at their campsite or flea market site under adult supervision
- **NOTICE:** Due to repeated past problems with irresponsible pet owners and aggressive animals, and for the enjoyment and safety of all of our guests, no pets* are allowed anywhere on the grounds during the festival. Please plan accordingly. *With the exception of service animals.

FORBIDDEN ITEMS

- **No toys may be sold that shoot any type of projectile**
- **No firearms or weapons of any type will be allowed**
- **KNIVES: Legal knives may only be sold to those 18 years of age and older with proper photo ID**
- **No animals are to be on display or in your booth**
- **No bug fogger use is allowed in the Flea Market area**
